1. WHO IS RESPONSIBLE FOR THE PROCESSING OF YOUR DATA?

2. WHAT IS PERSONAL DATA AND PROCESSING?

A personal data is that which identifies or allows to identify a person. For example, the data that can directly identify a person is the name and surname, while the ID number can identify them. Personal data includes information such as mobile phone, email address, date of birth and gender, among others. It could also include numerical identifiers such as the IP address of your computer, as well as the information obtained through cookies.

A treatment of a personal nature is any operation or set of operations that we carry out on your personal data, such as, for example, the collection, registration, conservation, use and communication of your data.

3. WHAT KIND OF INFORMATION DO WE COLLECT?

In order to correctly carry out the data processing collected in this Privacy Policy, we need to collect certain information about you. Therefore, we collect the information you provide us through the channels of interaction and communication with FLEXIBLECARHIRE.COM LTD. The data that we can collect about you through these channels are name and surname, ID number, email address, mobile phone number, address, purchase history, characteristics, preferences, tastes, responses to satisfaction surveys, opinions about products, delivery of orders, etc., data related to the method of payment, interaction with customer service, processing of claims and returns, information on profiles on social networks and information on the use and navigation of the web (web page from which you arrive at the Website, layers of the same visited, processes started and abandoned, IP address, time you have remained on the Website).

4. THROUGH WHAT WAYS DO WE COLLECT YOUR PERSONAL DATA?

At FLEXIBLECARHIRE.COM LTD we only collect and process information that you provide us through the following means:

4. Interaction with customer service;

5. WHAT ARE YOUR RIGHTS WHEN YOU PROVIDE US WITH YOUR DATA?

Next, we provide you with the rights that you can exercise as a user of the website:

Rights	What does it mean?
Right of access	You have the right to have FLEXIBLECARHIRE.COM LTD confirm whether or not it is processing your personal data and, if so, the right to know what data it is processing.
Right of rectification	It consists of the possibility that you can modify those data that are inaccurate or incomplete, and you must indicate in the rectification request what data you want to be modified.
Right of opposition	You can object at any time to the processing of your personal data, except in those cases provided by law. Thus, except in the cases in which it is legally established that you cannot exercise this right (for example, when the legitimate basis for processing your personal data is the execution of a contract or the fulfillment of a legal obligation on our part) You have the right to object at any time, for reasons related to your particular situation, to the processing of personal data concerning you. In addition, this right may be exercised when the data processing is based on our legitimate interest. In case you exercise this right, FLEXIBLECARHIRE.COM LTD will stop processing your personal data, unless we prove compelling legitimate reasons for the treatment that prevail over your interests, rights and freedoms, or for the formulation, exercise or defense of claims .
Right of deletion	This right allows the cancellation of your personal data. Once you exercise this right, your data will not be deleted immediately, but will be kept blocked in a way that prevents its treatment, without prejudice to its being made available to public administrations, judges and courts, for the attention of possible responsibilities that have arisen. treatment during its prescription period. Once this period has been reached, your data will be duly anonymized or deleted.

Right to data portability	You have the right to copy and transfer the data you have provided to us to a data controller other than FLEXIBLECARHIRE.COM LTD. 6. WHAT PROCESSES DO WE CARRY OUT WITH YOUR PERSONAL DATA?

We want to be transparent with you and inform you about the operations we carry out with your data and the purposes for which we process said data. For this reason, we have proceeded to separate the relative information into independent tables.

Each descriptive table of each processing of personal data collects the following information:

For what purposes do we process your data?

In this column we explain why and for what purpose we process your personal data.

- **What is the legal basis that legitimizes us for the treatment of your data?**

The data protection regulations require that for the treatment of your personal data we have a basis that legitimizes said treatment. Thus, to treat your personal information we rely on the following legal bases:

- **Legitimate interest:** As a company, FLEXIBLECARHIRE.COM LTD. has a legitimate interest in collecting and processing your personal data in order to study and analyze the suitability of our Website and products, study whether they adapt to the needs of our customers and users or, on the contrary, should be modified. In some specific aspect or they can be improved to better adapt to said needs or new market trends. It also has a legitimate interest in maintaining regular contact with its customers and users to keep them informed about its news, promotions and products and to recommend or offer them those products that best suit their needs, characteristics and preferences. In any case, this legitimate interest is based on an analysis of the proper balance of our interests in processing your personal data and your rights and freedoms. The result of said analysis will determine whether or not we can use your personal information for the treatments described in this Privacy Policy.
- **The execution of the contract:** at the moment that you expressly accept the General Conditions of Contract, you become part of the purchase contract of the product signed with us. In order for us to comply with the obligations contained in these General Conditions of Contract, we need to collect and process your personal data. Therefore, your refusal to provide us with the personal data that is necessary to process the General Conditions of Contract will imply the impossibility of you being able to buy products with FLEXIBLECARHIRE.COM LTD.
- **Legal Obligation:** FLEXIBLECARHIRE.COM LTD. acts as the controller of your data and that is why it must comply with a series of obligations imposed by accounting, tax, data protection, consumption, etc. regulations. Therefore, FLEXIBLECARHIRE.COM LTD will maintain the confirmation of those users who have requested the deletion of their data on a deletion list, in compliance with the legal obligation derived from Regulation (EU) 2016/679 of the European Parliament and of the Council, of April 27, 2016, regarding the protection of natural persons with regard to the processing of personal data and the free circulation of these data and by which Directive 95/46/EC is repealed.

At Flexible Car we use our own cookies so that you can browse the website with ease. These cookies are technical, so they do not require the User's consent.

This Cookies Policy explains what cookies are, how Flexiblecarhire.com LTD uses them. (hereinafter, "Flexible Autos") on its website <https://www.flexibleautos.com/> (hereinafter, the "Website") and how the user can manage them.

1. WHAT IS A COOKIE?

A cookie is any type of data storage and retrieval device used in a user's terminal equipment for the purpose of storing information and retrieving information already stored.
